



# PARTICIPANT REQUIREMENTS

- 1. RESIDENCY:** MUST BE A RESIDENT OF THE 50 UNITED STATES OR THE DISTRICT OF COLUMBIA.
- 2. AGE REQUIREMENT:** MUST BE AT LEAST 14 YEARS OF AGE TO ENTER. PARTICIPANTS UNDER 18 REQUIRE WRITTEN PERMISSION FROM A PARENT OR LEGAL GUARDIAN.
- 3. ENTRY FEE:** A NON-REFUNDABLE ENTRY FEE OF \$21 IS REQUIRED, WHICH INCLUDES ACCESS TO THE FUEL UP CHALLENGE APP.
- 4. HERBALIFE PURCHASE:** TO BE ELIGIBLE AS A WINNER, A MINIMUM PURCHASE OF \$100 IN HERBALIFE PRODUCTS OR CLUB CREDIT TO YOUR COACHES NUTRITION CLUB IS REQUIRED.
- 5. PROGRESS DOCUMENTATION:** WHILE BEFORE AND AFTER PICTURES AND MEASUREMENTS ARE NOT MANDATORY TO ENTER THE CHALLENGE, THEY ARE REQUIRED TO BE CONSIDERED FOR THE WINNING POSITIONS.

# OFFICIAL RULES

- 1. ACKNOWLEDGMENT OF RULES:** PARTICIPANTS ACKNOWLEDGE THE EXISTENCE OF AND UNDERSTAND THE OFFICIAL RULES AND AGREEMENTS OF THE FUEL UP CHALLENGE.
- 2. WINNER SELECTION:** WINNERS WILL BE CHOSEN BASED ON OVERALL BODY TRANSFORMATIONS, JUDGED BY A PANEL OF QUALIFIED JUDGES. TRANSFORMATIONS MAY INCLUDE WEIGHT LOSS, MUSCLE GAIN, OR INCREASED TONE AND MUSCLE DEFINITION. FOR PREVIOUS WINNERS, THEIR WINNING PICTURE WILL BE TAKEN INTO ACCOUNT TO PREVENT WINNERS FROM LOSING AND GAINING AND TRYING TO WIN AGAIN.
- 3. DIETING METHODS:** EXTREME OR UNHEALTHY DIETING METHODS ARE NOT SUPPORTED. CHALLENGERS FOUND ENGAGING IN SUCH PRACTICES WILL BE DISQUALIFIED.
- 4. PRIZE POOL:** THE TOTAL PRIZE POOL VARIES PER CHALLENGE. THIS DEPENDS ON THE TYPE OF CHALLENGE AND AMOUNT OF PEOPLE ENTERED IN THE CHALLENGE. THE AMOUNT WILL BE ANNOUNCED AT THE START OF THE CHALLENGE. THE PRIZE POOL IS UP TO \$10,000.00 USD, DISTRIBUTED AMONG THE TOP TEN TRANSFORMATIONS. NO INDIVIDUAL PRIZE SHALL EXCEED \$2,500.00 USD.
- 5. RELEASE OF LIABILITY:** BY ACCEPTING A PRIZE, WINNERS RELEASE ALL ASSOCIATED ENTITIES FROM ANY CLAIMS OR LIABILITIES ARISING FROM PARTICIPATION IN THE CHALLENGE.
